In view of Notification No. 54 dtd. 21.06.2021 of the Hon'ble Gauhati High Court, there shall be restricted court functioning with "Staggered roster" in all courts, so as to maintain social distancing.

All the courts shall function in virtual mode :

The following category of cases shall be taken up :-

- (i) Bail Matters.
- (ii) Remand matters.
- (iii) Recording of statement of accused persons U/S 313 Cr.P.C. by invoking sub-section (5) of Section 313 Cr.P.C.
- (iv) Injunction matters.
- (v) Cases pending for final arguments.
- (vi) Petitions seeking interim maintenance.
- (vii) Zimma petitions.
- (viii) Recording of statements u/s 164 Cr.P.C.
- (ix) Issuance of cheque to the claimants in MAC cases.
- (x) Rent deposit cases.
- (xi) Any other matter which is deemed to be of utmost important and urgency.

And in view of guidelines laid by the Notification No. 35 dated 01.05.2021 of the Hon'ble Gauhati High Court, the Roster Duty arrangement in respect of the Judicial Officers of this establishment as prepared earlier vide Order No. 137 dtd. 25.06.2021 is partially modified in view of Sri A. Bordoloi, Munsiff No.1-cum-JMFC, Hailakandi has resumed his official duty, as follows :-
