1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Candidates must not be less than 18 years or more than 38 years of age on 01.08.2021. However, for candidates belonging to reserved category, the age relaxation shall be as per existing Govt. norms.
3. The Candidates shall be required to appear in a driving skill test followed by Personal Interview.
4. Date, Venue, Time of the Personal Interview/Driving Test, list of eligible candidates etc. will be published in the official Website – www.hailakandijudiciary.gov.in. Candidates are requested to visit /check the official website from time to time.
