It is for general information that a meeting of the "Tender Committee" for outsourcing of vehicle is held on **17/07/2021 at 1.00 P.M.** in the office chamber of the undersigned to discuss the tender process along with MVI report submitted by DTO, Hailakandi vide letter no.DTH/853/2021 Dated 17.07.2021. Accordingly, the tenders submitted by Shri Jogotjyoti Paul and Shri Jamrul Islam Barbhuiya are summarily rejected due to the fact that same are not consistent with terms of tender dtd. 01/07/2021.

In result, a re-tender will be called for outsourcing of the vehicle for this establishment, in public interest.
