**Terms & Conditions:**

1. The vehicle should not be preferably more than 1 year old and the total running Kilo Meter Should be less than 20,000 km. But if no such vehicle is found, then for any other good conditioned vehicles, the criteria may be relaxed by the Board with suitable conditions.

2. The maintenance and toll of the vehicle shall be borne by the outsourcing vendor. But cost of driver and fuel will be borne by the Office of the undersigned.
3. The contract period will be initially for 1 (one) year, which may be extended (if necessary) or till new vehicles are provided by the Government.
4. The interested parties (vendor) must submit the sealed quotation containing tender along with their GST Registration Certificate, PAN Card, Vehicle Registration Card, Vehicle Insurance Certificate Experience Certificate (if any) etc.
5. The sealed envelope containing quotation shall be marked as "Quotation for Outsourcing Vehicle for C.J.M, Hailakandi".
6. Payments to the vendors shall be reimbursed through NEFT after submission of proper bills.
