Applications are invited till **5.00 P.M. of 10.12.2018** from the citizens of India as defined under Article 5 and 6 of the constitution of India in Standard Form as published in part IX of the Assam Gazette with self attested photocopies of all the testimonials in support of age, educational qualification, caste and experience, if any along with 03 (three) copies of recent passport size photographs for filling up the vacancies (existing + anticipated) for Peon, Chowkidar Day/Night for the establishment of District & Sessions Judge, Hailakandi in the scale of pay of **Rs. 12,000/- to 37,500/- with Grade Pay of Rs. 3900/-** (ROP – 2017) and other allowances admissible as per Rules. The number of vacancies shown below is indicative only and may vary on either side at the time of final selection.

A candidate is allowed to submit one application form only against one category of post as per his/her choice.

A common Written Examination will be held for selection to the said posts followed by Viva-Voce.

Eligibility criteria: - (i) A candidate must be Class VIII passed. Candidates having educational qualification above H.S.S.L.C. need not apply.

Terms & Conditions :-

- (i) Merely satisfying eligibility criteria will not entitle a candidate to be called for the written examination / interview etc.
- (ii) Candidate who are already in Government service may apply through proper channel with NOC from employer.
- (iii) Incomplete application will be rejected without informing the applicant.
- (iv) The certificate for claim of reservation must have been issued by the competent authority and the self attested copy of the same should be enclosed with the application.
- (v) Candidate should submit along with the application, a self addressed envelop measuring 3'' X 6.5'', affixing Postage Stamp of Rs. 5/- on it.
- (vi) No T.A. / D.A. will be paid for appearing the written test/ Interview.
- (vii) Candidate should mention their Mobile Number in the application and the name of the post on the top of the envelope containing application.
