The Chief Judicial Magistrate, Hailakandi invites Sealed Quotations affixing Court Fee of Rs. 8.25 (Non-refundable) from reputed firm/NGOs for "**Housekeeping, Sweeping and Cleaning Services**" for Chief Judicial Magistrate Establishment, Hailakandi.

Interested Firm/NGOs having satisfactory experience in the field are hereby asked to submit their quotations in the Drop-Box installed in the Office of the undersigned w.e.f **10.00 AM of 24th May, 2023 till 5.00 PM of 7th June, 2023.**

General Terms & Conditions:

1. The parties shall have to submit photocopies of their registration certificate, trade licence, income tax return file (latest three years), Pan Card, bank account details etc.
2. The Tender shall be valid for the Financial Year 2023-24. Further, prayer for discontinuation of service, if any, should be prayed before Ld. Chief Judicial Magistrate, Hailakandi on or before 3 (three) months of the date of discontinuation intended.
3. The rate of tender should be quoted with GST component separately. Moreover, the rate quoted shall be final and no increase in the same shall be entertained for the period of one year from the date of agreement.
4. The rate should include expenses for cleaning articles like phenyl, cleaning agents like harpic, bleaching powder, floor cleaner, mop sets, odonil, etc. but said rates are not required to be shown separately, but only a consolidated rate should be quoted.
5. The tenderer should ensure the number of housekeeping staffs present should be minimum of 03 (three) persons, round the clock.
6. The cleaning and housekeeping activities shall include, but not limited to, round the clock clearing and sweeping, moping, dusting of doors, windows, furniture, table, chairs, court ejlash, curtains etc. of the Chief Judicial Magistrate Establishment (Building) along with C.J.M. Bungalow, Hailakandi, Office, Chamber, Toilet of the Asstt. Dist. & Sessions Judge, Hailakandi, cleaning of ground floor to 3rd floor of C.J.M, Establishment including all the chambers of Officers and toilets, Courts including chambers and toilets of

M.M.I cum JMFC, Hailakandi and M.M.II cum JMFC, Hailakandi and office, chamber and toilet of the Secretary, DLSA, Hailakandi and cleaning and maintaining of the bushes in and around the all campus etc.

7. The housekeeping staffs should present in the establishment from 08.00 A.M to 03.00 P.M and they shall ensure proper cleaning and sweeping.
8. The Chief Judicial Magistrate, Hailakandi shall have the right to accept or reject any tender and shall not be bound by the lowest price quoted.
9. The Chief Judicial Magistrate, Hailakandi shall have the right to cancel the tender at any point of time without giving notice, if the service is found unsatisfactory and the decision of the Chief Judicial Magistrate, Hailakandi shall be final.
